CA STATE BOARD of EQUALIZATION: All Artists MUST hold a valid Seller's Permit number. This number is REQUIRED on the application and will be checked on the CA-BOE website prior to any acceptance

ADDITIONAL SALES AFTER THE SHOW

If you have additional sales after the show, we trust that you will pay the additional 10% commission at a later time. Should we learn about follow on sales that are not reported, you will not be accepted into future LARC Fine Art shows.

CANCELLATION

Refunds only given if notice of cancellation is received prior to March, 1st 2018. NO exceptions.

SECURITY OF ARTWORK

Although security is provided, the LARC is not responsible for loss or damage.

JURY INFORMATION

Over the years, our show has built a reputation and success based on the high quality of the fine artists and crafts people who are selected by our jury panel. The jurors are volunteers who have backgrounds in various art disciplines and are familiar with our show. They will view your photos with an eye at balancing our presentations to the public. How you display your work weighs heavily in the Jury process.
